**RULES & REQUIREMENTS**

**I. Concept**

- a. Holiday/Winter-Themed Wreaths
- b. Holiday/Winter-Themed Gingerbread Houses

**II. Authority of the Committee**

- a. The Scents & Sweets Sub-Committee reserves the right to refuse any entry on arrival that does not, for whatever reason, adhere to the entry requirements of the Committee as stated below.
- b. Competition participants agree to abide by all entry requirements and decisions of The Scents & Sweets Sub-Committee. Any misrepresentation or failure to abide by the Sub-Committee requirements is grounds for removal from the competition.

**III. Application**

- a. Applications with entry fee must be postmarked by or turned into the Office of Special Events Friday, November 15, 2024.
- b. Late applications are not accepted.
- c. Your application is not considered complete until we receive your entry fee. We accept the following types of payment:
  - Cash
  - Check (payable to Celebrate Frederick)
  - Credit Card (accepted in person or over the phone – there is a 3% processing fee.)

**IV. Awards and Recognition**

- a. Participants in the Child Individual and Child Group gingerbread category receive a participation ribbon.
- b. Prizes are awarded the night of the competition as follows:

**V. Delivery, Display, and Pick-up**

- a. **Delivery:** Approved entries must be hand-delivered to New Spire Arts on Thursday, December 5 between 10 AM and 3 PM.
- b. **Display:** Entries are on display at New Spire Arts on Thursday, December 5 from 5:30 to 7 PM.
- c. **Pick Up:** Immediately following the reception, all entries must be picked up. (The Holiday Committee will remove any entries left behind.)



## VI. Entry Requirements

- a. Entries must be original in design and personal execution.
- b. Entries should reflect the theme of "The Holidays."
  - i. Gingerbread structures are not limited to houses (E.g., historic buildings, religious institutions, Frederick buildings, etc.).
- c. Guidelines

### i. Gingerbread

1. Gingerbread House must be constructed of gingerbread dough made from scratch. (Child individual or group entries are given the option of using a kit for construction.)
2. Size -
  - a) All entries must be three dimensional.
  - b) The base of all entries must not exceed 25" x 25". (These dimensions include all landscaping and surrounding figures.)
  - c) There are no height restrictions on each entry.

### ii. Wreaths

1. All wreaths must be original and handmade.
  - a) Wreaths can be constructed of live and/or artificial flowers and greenery, or other materials. Perishable food items are prohibited.
2. Size -
  - a) Wreaths must be of a shape so that they have a center hole with a minimum diameter of 4".
  - b) Wreaths must be a minimum of 12" diameter and must be no larger than 28" diameter.
3. Weight -
  - a) Wreaths cannot exceed 5 lbs.
4. Decorations -
  - a) Secure all decorations firmly to the wreath base. (Coated floral wire is ideal.)
  - b) Free-standing decorations are not permitted.
  - c) Wreaths with electrical components must be self-contained (battery operated). You may not plug in your wreath to an electrical outlet.
  - d) Entries are displayed on a standard wreath hook, easel, or upright flat surface. Wreaths must have a hook affixed to the top past the midline.

## VII. Judging

- a. Judging is based on the entries which best reflect the holiday theme.
- b. Winners are decided by a panel of judges and popular vote.

## VIII. Silent Auction & Proceeds

- a. Auction
  - i. The silent auction will take place from 5:30 PM – 7 PM on December 5<sup>th</sup>.
  - ii. Submissions are auctioned at a minimum bid.
  - iii. Following the auction, payment is accepted in the form of cash, check, or credit card.
- b. Proceeds from the auction benefit Celebrate Frederick's many free community events.
